





 - Inflation






Federal Funded Grant Project

181st Safety Project – Burnside to Stark

- Congressionally Directed Spending
- Starting engagement in June
- Design elements determined with public input

181st Crossings Project – whole corridor

- Based on Metro Funding Measure 2020
- \$16 million for 8 new crossings, medians, buffered bike lanes
- Not awarded February 2024



What's Next for Grants?

2024 SRTS Construction Grants

Criteria focused on higher equity needs schools (BIPOC, low-income, Ever English learners)

- Palmquist Road (Hogan Cedars ES) sidewalk infill
- 194th Avenue (Davis ES) traffic calming
- Birdsdale Avenue (Hollydale ES) traffic calming
- NE 188th sidewalk infill and crossing improvements
