Help for Homebuyers

The City of Gresham's WELCOME HOME program provides interest-free down payment assistance loans to qualified homebuyers.

PROGRAM BENEFITS:

- Interest-free, shared appreciation loans from \$10,000 to \$20,000 depending on financial need.
- Loan forgiveness after 15 years in residence.

PROGRAM QUALIFICATIONS:

The WELCOME HOME program offers interest-free down payment assistance loans to households that...

- Are first-time homebuyers or have not owned a home in the past three years.
- Qualify for a primary mortgage with an Oregon licensed lender.
- Are purchasing a home in Gresham with a sale price that does not exceed \$352,000.
- Will live in the home as their primary residence.
- Make 80 percent or less of the federal annual median income:

WELCOME HOME LOAN PROGRAM OVERVIEW

Gresham's WELCOME HOME Program can loan up to \$20,000 to help **qualified first-time homebuyers** pay for down payment and reasonable closing costs. A WELCOME HOME loan is a zero-percent interest deferred-payment, shared appreciation loan that is forgiven at the end of 15 years.

Follow these steps to apply for a Welcome Home loan:

- 1. You, the **Buyer**, must get pre-qualified for primary financing by an Oregon-licensed lender.
- 2. The **Buyer** contacts Portland Housing Center (PHC) to set up an appointment for an intake interview.
- Portland Housing Center obtains necessary documentation from Lender and/or Buyer to
 complete underwriting review to determine whether the borrower is eligible for assistance, and if
 so, the amount of assistance.
- 4. The **Buyer** must complete an eight-hour homebuyer education class provided by Portland Housing Center once approved for assistance.
- 5. The **Buyer shops** for an eligible property --- finds an affordable house that is in **excellent** condition.
- 6. Buyer provides property address to PHC for PHC to determine if the property is eligible for assistance, subject to the final inspections.
- 7. **Buyer and Seller** sign a purchase/sale agreement and required forms.
- 8. The **Buyer** orders and pays for whole house inspection and pest & rot inspection
- 9. The **Lender** submits a complete application packet to Portland Housing Center. The packet must include:
 - 1. The home inspection report
 - 2. The pest and dry rot report
 - 3. A completed WELCOME HOME inspection request form
- 10. City of Gresham completes a Housing Quality Standard (HQS) inspection of property.
- 11. Portland Housing Center prepares documents for signature.
- 12. **Portland Housing Center** sends all required documents to the City of Gresham for signatures and processing loan agreement.
- 13. **City of Gresham** coordinates with the Title Company to provide funding and secure recorded documents on property
- 14. You, the Buyer, sign final paperwork, and move into your new home. WELCOME HOME!
