Meeting Purpose

This work session will include an update from staff on the Tree Code Project's Phase 2 community goals outreach and the feedback received as well as a review of the project's next steps. Staff will request feedback from the Planning Commission on the community goals as well as what priorities the Commission may have for developing project alternatives as we move into Phase 3: Alternatives.

Project Background

The tree code was last changed in September of 2020, when Council voted to adopt amendments to tree regulations in the Development Code. These amendments reformatted the tree regulations; however, they did not update the tree policies and related content. Concerns have arisen from residents, staff, and developers regarding the complexity of tree processes, enforcement challenges, and the appropriateness and effectiveness of the standards. This project is an opportunity to look holistically at the City's tree management priorities and policies, and work with the community to update them.

Tree Code Project Overview

The Tree Code Project team is working with the community to update Gresham's tree goals, policies, procedures, and regulations to reflect community goals, best practices in urban forestry and green infrastructure, climate resilience and climate justice, community vibrancy, and the guiding principles of the 2022-2025 Gresham Strategic Plan. The project is part of the Community Vibrancy action items (CV-D1) on the year three action plan to implement the goals of the 2022-2025 Gresham Strategic Plan. It includes high levels of community engagement and collaboration and will result in updates to Volumes 1-3 of the Community Development Plan, as well as updated tree lists and the creation of a city tree guidebook. The project was initiated by the City Council on July 18, 2023, and it is anticipated to run through late summer of 2025, with additional implementation work after the code updates are adopted.

Project Purpose

Gresham has a thriving and equitably distributed tree canopy that supports climate resiliency and healthy living.

Project Guiding Principles:

- *Collaborate* with external partners and community members to determine outreach/engagement strategies and set policy priorities/project outcome goals.
- *Involve* partners and community members in drafting of policy language to ensure policies match goals and limit unintended consequences of new policy.
- *Integrate* a climate (and climate justice) lens into the project process and policies.
- *Apply* an equity lens to the project process and policies to support early and intentional attention to eliminating inequities and advancing fair treatment.

Community Goals Feedback Overview

The community outreach participants shared that trees in our city are very important to the community, and that they would like our updated tree policies to:

- Protect mature trees and groves of trees;
- Support a high level of tree coverage;
- Promote places with a variety of tree sizes and building sizes;

- Reduce urban heat;
- Provide wildlife habitat;
- Improve air quality; and
- Support healthy living.

As we move into Phase 3: Alternatives, the project team will look at how to craft policies to support these community goals.

- Neighborhood Coalition: Staff will be attending the December 10th meeting of the Coalition of Gresham Neighborhood Associations to review project progress and community goals and to discuss the development of project alternatives.
