II. Type IV Public Hearing: 2024/25-2028/29 Capital Improvement Program (CIP) (CWP-24-00105)

Chair Rustad-Smith reviewed the opening statement.

Order of Procedure

Application number CWP-24-00105 is an application to adopt the 2024/25-2028/29 Capital Improvement Program (CIP) for the City of Gresham, Oregon. Projects are being proposed for the following programs: Wastewater Collection and Treatment Plan, Water, Transportation, Footpaths and Bikeways, Parks, Trails and Open Space, General Development, Stormwater, and Urban Renewal.

Councilor Hinton reported that the City of Gresham will be receiving federal funding of one million dollars for wastewater treatment plant improvements, two million dollars for Gradin Sports Park, and three million dollars for transportation upgrades on 181st Avenue. He also announced that he learned at his recent trip to DC with lobbyists that the Federal Government will be funding the I5 Bridge replacement. Councilor Hinton also shared that the Gresham Police Department just solved a cold case from 1980.

Commissioner Schroeder reported that the Urban Forestry Subcommittee met recently and gave a quick update.

Commissioner Round-Robin

Vice-Chair Kamp reminded the Commission that the Public Safety Levy would be on the ballots in May.
