Multnomah County Update by Commissioner Lori Stegmann, supported by her chief of staff, Rebecca Stavenjord

Commissioner Stegmann introduced herself as a proud resident of Gresham and an advocate for East County. She provided an overview of services provided by the county and services provided through the Joint Office of Homeless Services. She described efforts to set numerical goals and measure impact of various programs provided by the Joint Office of Homeless Services. For example, one goal is to see a 50% reduction in unhoused people by December 2025.

Multnomah County has responsibility for the Public Health Department. She described efforts to behavioral health services and researching best practices in other jurisdictions, such as Houston TX. She described the challenges of recruiting and retaining community health workers and programs to certify new staff.

Questions to Commissioner Stegmann:

Q: Why has Multnomah County stopped the wastewater monitoring for COVID-19. A: Monitoring has moved to the state – the Oregon Health Authority is now responsible for all wastewater monitoring.
